

APPLICATION FORM & REQUIREMENTS FOR KDCA WEBSITE LISTING

Breeder listings are subject to approval by the KDCA Board of Directors.

Requirements:

1. Be members in good standing of the KDCA for at least one full year and sign the attached agreement with the KDCA Constitution, Mission, and Code of Ethics.
2. Send this completed application form to the KDCA, along with a \$25 fee, to be renewed annually before January 31st.
3. Provide a clear and prominent link (with the text "Member, Kangal Dog Club of America") from their main breed-related web page to the KDCA website, kangalclub.com, as an indication of support for the Club, and to provide the public with access to the information resources of our club's website.
4. Ensure that the pedigree information of all dogs owned or co-owned has been submitted for inclusion in the KDCA's Health and Pedigree database, including pedigree information on all current puppies.
5. Prior to breeding, ensure that any dogs owned or co-owned have had their hips evaluated by either OFA or PennHip, and a photocopy of the official results provided to the KDCA Health Committee.
6. Listed breeders will ensure that all dogs that they own and that will produce a litter after March 1, 2011 will be DNA-certified using the UKC's DNA service. Proof of DNA certification must be sent to the KDCA club secretary within 6 months of producing a litter when breeding dogs that have not previously been DNA certified.
7. Adhere to any written contract with the original breeder and/or co-owner of a dog with respect to breeding permissions, hip certification, etc.
8. All dogs/puppies being sold are owned or co-owned by the breeder.
9. Listed breeders should encourage all of their buyers to join the KDCA and will offer them, in writing, a one-year associate or regular membership in the club, to be paid for by the breeder if the buyer agrees to join the club.
10. Breeder listing on our club site is a privilege which assumes that participants will work for the best interests of the club and breed.
 - The KDCA will provide listed breeders with a link to their websites and/or email addresses.
 - Listed breeders can send in litter announcements to the KDCA Board so that these can be included in any future newsletters published by the club.
